1. He Dâh hi hman a nih aṭang chuan TP hnuai mirawih Pension-a kalte chu TP-in an Pension-na tur Budget-ah dahin a pe ṭhin ang.
2. PENSION HMU THEI TURTE:
Hna ngheta thawk tura lak, an dinhmun tih ngheh Pension zawm tawhte an ni ang.
3. PENSION THEIH DAN CHI HRANGTE:
He Dânah hian heng Pension chi hrang hrangte hi a awm ang:
 - a) Superannuation Pension (upat pension)
 - b) Retirement Pension (thawk rei tawh pension)
 - c) Voluntary Pension (mahni duhthlan-naa pension)
 - d) Compulsory Pension (pension luih tir)
 - e) Invalid Pension (hna thawk zui thei lo pension)
 - f) Family Pension (thawktu thi chhungte dawm zuina)
4. SAWIFIAHNA:
 - a) ***Superannuation Pension:*** Superannuation Pension chu mirawih kum 60 pumhlum tawh, kum 15 pumhlum thawk tawh chin hnena pension pek hi a ni.

- b) **Retirement Pension:** Retirement Pension chu mirawih kum 30 thawk pumhlum tawh chin hnena pension pek hi a ni.
- c) **Voluntary Pension:** Voluntary Pension chu mirawih kum 15 pumhlum thawk tawh chin, kum 60 la tawng si lova mahni duh thua pension-a kal dil, ruaituin a phalsakte hnena pension pek hi a ni.
- d) **Compulsory Pension:** Compulsory Pension chu mirawih kum 15 thawk pumhlum tawh chin, kum 60 la tawng si lo, ruaituin a pension luih tirte hnena pension pek hi a ni.
- e) **Invalid Pension:** Invalid Pension chu mirawih nghet tura lak, kum khat thawk tawh (Confirmed/ Permanent-a dah tawh), vanduaina tawk emaw, hrisel lohna avang emaw, Doctor-in a hna thawk zawm thei tawh lo tura a tihte hnena pension pek hi a ni.
- f) **Family Pension:** Family Pension chu mirawih nghet tura lak kum khat thawk tawh (Confirmed/ Permanent-a dah tawh), thi chhungte hnena dawmzuina pek hi a ni.

5. PENSION CHHUT DAN TUR:

Pension chhut dan tur hetiang hian a ni ang:

“Superannuation Pension, Retirement Pension, Voluntary Pension, Compulsory Pension, Invalid Pension, Family Pension-a kalte, an pension dan a zira thlatina an hmuh theih dan tur chhutna (formula) chu hetiang hi a ni:

$$\text{Thlatin Pension} = \frac{\text{Hlawhpui} \times \text{Pensionable Service}}{40}$$

6. DEARNESS RELIEF:

- a) He Dân hman aṅga an pension hlawh pangngai phak lote chu Dearness Relief aṅgin a ṅul anga pek belh theih an ni ang.
- b) Tuna pension lai mekte D.R. hi Basic-a bet tawh lovin, thawktu dangte D.A. pun dan rate dungzuia D.R. pek tur a ni ang.

7. RETIREMENT PENSION-A KAL THEIH DAN TUR LEH QUALIFYING SERVICE:

a) ***Retirement Pension-a kal theih dan te:***

- i) Mirawih kum 30 thawk pumhlum tawh chin chuan chawlh a duh hun hma thla 3 aia tlem lovah, ziaka Pension-a kal dilna a pekin full pension-in a kal thei.
- ii) Mirawih kum 30 thawk tawh chin chu, ruaituin chawlh tir a duh hun hma thla 3 aia tlem lovah hriattirna pein emaw, a thla 3 hlawh pein emaw full pension-in a kaltir thei.

- b) ***Qualifying Service:*** Mi rawih hna thawh ṅanna chu a Service chhiar ṅanna atan hman tur a ni a. A ṅanna chu a nghet nghal emaw, nghet lo (Officiating, Probation, temporary, apprentice, contract) pawh ni sela, chawlh lawk awm lova thawk zawm a nih chuan Pension hun chhiarna atan chuan hman vek tur a ni.

Tin, Service kum 30 pumhlum chin hi full pension-a kal theihna tur a ni a. Mirawhin kum 30 aia tam pawh thawk sela, Pension chhutna atan chuan kum 30 aia tam hman theih a ni lo vang.

8. MEDICAL ALLOWANCE:

Pensioner-te Medical Allowance ₹ 300/- p.m. pek a ni ang.

9. INVALID PENSION PEK DAN TUR:

Invalid Pension-a kalte chu a hnuai mi ang hian Pension pek an ni ang:

- a) Kum 15 pumhlum leh a aia rei thawkte chu Rule No. 5-na angin a pension-na tur chhûtsak a ni ang a, Dearness Relief 44% pm Pension Basic a hmu tel bawk ang.
- b) Kum 15 la thawk tling lote chu hetiang hian chhutsak an ni ang. An hna an chawlhsan chiaha an hlawhpui (basic pay) atanga 20% an hmu thei ang a D.R. 44% pm an hmu tel bawk ang.
- c) D.R. hi a tul anga enthat zel theih a ni ang.

10. FAMILY PENSION PEK DAN TUR:

Family Pension chu a hnuai mi ang hian pek a ni ang:

Family Pension hmute chu last pension basic pay atanga chhutin 40% pek an ni ang. Hei hi ₹ 1,000/- (cheng sangkhat) aiin a hniam tur a ni lo vang.

NOTE: Family Pension dawng thei turte —

- a) Mirawih thi ta kawppuiin (i.e. nupui/pasal) kawppui dang a neih leh hma zawng emaw, a thih thleng emaw, a hmasa zawk zawk.

Mirawih thi chu Hmeichhia a nih a, a pasalin nupui dang a neih leh chuan a fate enkawlzui thei tura ngaih a nih avangin Family Pension hi a faten an hmu zui thei lo vang.

b) *Mirawih thi ta fate*: Family Pension latu chu a thihin emaw, hmeichhia a nih a, pasal dang a neih leh emaw chuan mirawih thita fate zinga kum la tling lo ten a upat dan indawtin kum an tlin hma emaw, kawppui an neih hma emaw chu an la zui ang. Amaherawhchu, he mi hma pawhin thlatin hlawh lakna nghet an neih chuan Family Pension hi an hmu thei tawh lo vang. Kum tling hi mipa tan kum 22 a ni a, hmeichhe tan kum 24 a ni.

11. PENSIONER KOHHRAN DANGA PAKAITE TIH DAN TUR CHUNGCHANG:

Kan Kohhrana Pensioner, kan Kohhran chhuahsan emaw, Kohhran danga pakaite emaw chu an pension tihtawp a ni ang.

12. PENSION FUND SIAM ZUI DAN TUR:

Pension Fund sum tling khawmsa belhchhah nan hian Presbytery-in Pension Fund atan a budget thin ang a, chu fund atang chuan Pension etc. hi pek zel a ni ang.

NOTE: **Duh thlan theihna** —

Heng Pension Dân leh Contributory Provident Fund Dân hi mi pakhat tan hman kawp theih a ni lova, duh zawk zawk thlan theih a ni.

Pension Dân thlangte chuan General Provident Fund-ah pawisa an dah ang a, Contributory Provident Fund Dân thlangte erawh chuan C.P.F.-ah hian pawisa an dah ang.

13. UNUTILISED EARNED LEAVE PEK THU:

T.P. hnuaiia thawktute an pension dawna harsa taka an chhuak thin tihziaawm nan Unutilised Earned Leave/

Leave Encashment pek a ni ang a, hei hian ni 240 thleng a huam ang.

Hei hi General Fund aṅanga pek tur a ni. Hei hi a hlawh lak hnunung ber aṅanga chhut tur a ni ang.

PENSION HLAWH:

C.P.F. khinna leh Pensioner hlawh tur a remchan ang zelin Presbytery Budget-ah dah ṭhin a ni ang.

3. DEATH GRATUITY:

Mirawih ngheh emaw, a nghet lo emaw pawh a thih chuan a hnuaia mi ang hian Death Gratuity pek a ni ang —

- a) Kum 5 la thawk pumhlum lo chu a hlawh hnukung ber (last basic pay) let 3 leh ralna ₹ 20,000/- (cheng singhnih).
- b) Kum 5 thawk pumhlum tawh, kum 10 la thawk pumhlum lo chu a hlawh hnukung ber (last basic pay) let 4 leh ralna ₹ 20,000/- (cheng singhnih).
- c) Kum 10 thawk pumhlum tawh, kum 20 la thawk pumhlum lo chu a hlawh hnukung ber (last basic pay) let 5 leh ralna ₹ 20,000/- (cheng singhnih).

d) Kum 20 thawk pumhlum tawh leh a chung lam chu a hlawh hnuhnung ber (last basic pay) let 6 leh ralna ₹ 20,000/- (cheng singhnih).

4. GRATUITY CHUNGCHANG:

Service Gratuity leh Death Gratuity pek dan tur chungchangah chuan thawktu GPF/CPF zawm lote chu anmahni department in tha a tih angin a rel thin ang a, ama department sum atangin a pe thei ang.

BUNG - III

GENERAL PROVIDENT FUND DAN

General Provident Fund (GPF) chu Presbytery hnuai mirawihin thlatina a hlawhpui (basic pay) atanga Presbytery Pension & Provident Fund Board-in pek tur zat a ruat, Board a pek luh thin chu a ni a, hei hi Presbytery-in a khing lo vang.

1. GENERAL PROVIDENT FUND-A PEK TUR ZAT:

Mirawihin thlatina hlawhpui (basic pay) atangin Board-in a dah zat tur a tuk aia tlem lo a dah thin ang a, a tam lam erawh chu a dahtu thu a ni thung ang. Kum khat chhungin wawi khat tihdanglam theih a ni ang.

2. PEK LUH DAN:

Mirawih GPF chu a thawhna department-in thlatin a hlawh atanga cut sakin Pension & Provident Fund Board-ah thlatin ni 15 hmain a chhung lut thin ang.

3. FUND ENKAWL DAN:

GP Fund pawisa hi Board-in him tawka a hriat Scheduled Bank, etc.-ahte a pung that theihna ber turah a dah thin ang a, a enkawltu tur a ruat thin ang.

4. PAWISA PUNG CHUNGCHANG:

Hetiingin: He pawisa pung chu Board-in kum tin December thla tawpah a chhut chhuak thin ang a, Bank interest ang zela a pung chhut thin a ni ang. Account-a ziak luh fel a nih hnuah a dah zat leh a pung zat a neitu hnenah a hriattir thin ang.

5. FUND LAK CHHUAH THEIH DAN:

- a) Mirawih kum 15 thawk tawh chuan GP Fund-a a sum neih 75% rulh leh ngai lovin dilna form hmanga dilin a la chhuak thei ang.
- b) Mirawih a thi emaw, a hna atanga a chawhlin emaw, a pension-in emaw, GP Fund-a a sum neih zawng zawng dilna form hmanga dilin (a dah leh a pung) a la chhuak thei ang.

6. G.P. FUND-A SUM DAH PUK THEIH DAN:

G.P. Fund-a sum dahtuin a sum dah tawh atanga 80% aia tam lo, dam loh thilah leh In leh Lo dinna atan leh tul zual bik thilah chauh a pung awmin a pûk thei ang a, a pung zat chu enkawltu Board-in Bank-a a dahsak pung zat ang a ni ang. A pûk dan turah chuan form hmanga dil tur a ni a, pûk diltu thawhna department hotuin a puk duh chhan chu rintlaka a hriat a, a recommend-te chauh Board-in a pûktir ang.

7. G.P. FUND PUK RULH DAN:

A rulh dan chu sum pûktuin a pûk atanga thla hnih (two months) aia tlai lovah a rul tan ang. Kum 5 chhungin a pung nen a rul zo ngei tur a ni. Hemi hmaa a pûktuin rulh zawh a duh chuan engtik hunah pawh a vaiin a rulh zawh phalsak theih a ni ang a, a pung pawh chhut thatsak a ni ang.

1. DAN HMING:

He Dân hi Presbytery Employees Contributory Provident Fund Dân vuah a ni ang a, Contributory Fund Dân kalhmang zui a ni. Hei hian Retirement Gratuity leh Death Gratuity a keng tel ang.

2. CONTRIBUTORY PROVIDENT FUND ZAWM THEI TURTE:

Presbytery hnuaiaw mirawih, hna ngheta thawk turalak leh Permanent post-a awm ten an zawm thei ang. Zawmtu tur chuan a dilna form hmangin a dil thei ang a. Board/Office-ah a pe lut ang.

3. CONTRIBUTORY PROVIDENT FUND-A PEK TUR ZAT:

Mirawhin a hlawhpui (basic pay) atangin Board-in pek tur a tih zat chu thlatin a pe ang.

4. PRESBYTERY KHINNA:

Mirawhihin thlatinaw Contributory Provident Fund-a a dah zatin Presbytery-in thlatinin a khing thin ang a, CPF zawmtu ta a ni ang.

5. PEK LUH DAN:

Mirawih Contributory Provident Fund chu an thawhna Department-in thlatinin a hlawh atanga cut sakin, Pension & Provident Fund Board-ah thlatin ni 15 hmain ruaitu khinna nen an pe lut thin ang.

6. FUND ENKAWL DAN:

a) He Fund pawisa hi Board-in him tawka a hriat Bank, etc. a pung that theihna ber turah a dah thin ang a, a enkawltu tur a ruat thin ang.

b) He Fund-a pawisa hi Board-in interest pek zat tur a rel angin kum tin December thla tawpah a chhut chhuak thin ang a, account-a ziah luh fel a nih hnuah a dah zat leh a pung zat a neitu hnenah a hriattir thin ang.

7. FUND-A PAWISA PUK THEIH DAN:

He Fund-a pawisa hi Fund zawmtuin a sum dah tawh atanga 80% aia tam lo dam loh thilah leh In leh Lo dinna atan leh tul zual bik thilah a pung awmin a puk thei ang a, a pung zat ang a ni ang.

A pûk dan turah Form hmanga dil tur a ni a, pûk diltu thawhna department hotuin a pûk duh chhan chu rintlaka a hriat, a recommend-te chauh Board-in a pûktir thin ang.

8. FUND-A PAWISA PUK RULH DAN:

A rulh dan chu sum pûktuin a pûk atanga thla hnih (2 months) aia tlai lovah a pung nen a rul tan ang a, kum 5 chhungin a pung nen a rul zo ngei tur a ni. Hemi hmaa a pûktuin rulh zawh a duh chuan engtik hunah pawh a pung nen a zavaiin a rulh zawh phalsak theih a ni ang a, a pung pawh chhut thatsak a ni ang.

9. FUND ATANGA LAK CHHUAH CHUNGCHANG:

10. RETIREMENT GRATUITY:

Mirawih kum 2 leh a chung lam thawk tawh, lungawithlak taka chawl (retired)-te hnenah Bung II-naa mi angin Retirement Gratuity pek a ni ang.

Note: Gratuity hi ₹ 60,000/- (cheng singruk) aia tam chu pek theih a ni lo vang.

11. DEATH GRATUITY:

Mirawih ngheh emaw, a nghet lo emaw a lo thih chuan Bung II-naa mi ang bawkin Death Gratuity pek a ni ang.

12. G.P.F. leh C.P.F. HMAN DAN:

Heng Pension Dân GPF (Bung 3-na) leh CPF (Bung 4-na) te hi mi pakhatin hman kawp theih a ni lova, a zawmtuin duh a thlang thei ang.
